MMIWR Presentation

On February 5, the League of Women Voters of Marquette County hosted Caroline LaPorte, the department head and associate professor of Native American studies at Northern Michigan University. She gave a special presentation on the epidemic of Missing and Murdered Indigenous Women and Relatives (MMIWR) in the United States and Canada.

Center (NIWRC), and expert in Indian country law. She has also published work and made significant contributions to federal legislation like the Violence Against Women Act, the Not Invisible Act, and Savanna's Act. LaPorte is an immediate descendant of the Little River Band of Ottawa Indians and was elected as the associate judge for the Tribe in 2021.

The League's regular membership meeting space was packed, with nearly 90 attendees, including 42 non-members. The event was proposed and organized by the League's Diversity, Equity, Inclusion, and Accessibility (DEIA) committee, which strives to ensure that our local chapter represents the diverse communities of Marquette County while promoting equitable access to voter services.

LaPorte's presentation outlined how the forced removal of Indigenous peoples from their ancestral homelands has perpetuated colonial violence, particularly against Anishinaabekwe (Anishinaabe women), and how the epidemic of MMIWR stems from the breakdown of Indigenous social structures caused by federal policies like the Indian Civilization Fund Act 1819 and the Indian Removal Act of 1830.

"The inconsistent handling of violent crimes against Native women reaches far beyond the lack of training or failure of individuals to respond appropriately to such crimes," LaPorte said. "It is current federal law based on the historical relationship between the United States and Indian tribes as governments that shape the current legal authority over such crimes. This historical legal relationship also serves as the foundation for American cultural tolerance of violence against Native women."

LWVMC updates its land acknowledgment

For thousands of years, Marquette County has been home to Indigenous communities. A land acknowledgment recognizes these communities and their historical and current connection to the land.

In October 2021, Jo Foley and Sandy Breitenbach met with Amber Morseau, former director of the center for Native American Studies at the Center for Native American Studies (CNAS) at Northern Michigan University to discuss writing a League-specific land acknowledgment. This was a collaborative effort, with Amber Morseau, suggesting we use the one used at NMU and also allowing us to post their graphic created by Reese Carter at our meetings. In December 2023, we met again at CNAS, this time with Assistant Professor, Jud Sojourn, to get advice on making our statement more meaningful and personal. We decided to add historical, cultural, and current issues important to the Native American communities to help educate the membership.

Our latest version, written by Andie Balenger, includes more details on Treaties responsible for the loss of land and ensuing consequences because of that loss, like the breakdown of Indigenous social structures leading to violence, specifically against Anishinaabe women. It references action groups associated with current crises, including Missing and Murdered Indigenous Women and Relatives (MMIWR) and the Violence Against Women Act (VAWA). It also includes a link leading to more information. This new acknowledgment, a result of a collaborative process, will be read at the beginning of our membership meetings, posted on our website, and included in our newsletters.

Here it is.

The League of Women Voters of Marquette County remains committed to advocating for the rights of women, girls, and relatives, as outlined in the Violence Against Women Act (VAWA), through education, awareness, and advocacy.

Shoreline Cultural Trail

The City of Marquette is developing the Shoreline Cultural Trail, a seven-mile interpretive space along Lake Superior's coast that stretches from the mouth of the Carp River to Presque Isle. This initiative aims to honor and preserve the community's entire history and prompt curiosity about local heritage and the natural environment through new public spaces, public art, and digital content. The first significant trail installation is a sculpture titled "Seven Grandfather Teachings" by Anishinaabe artist Jason Quigno, located at the entrance of the newly renovated pier in Lower Harbor.

The trail will activate the City's shoreline with eight story markers, which will be installed in June 2025. The signs will blend public art, design, wayfinding, language, narratives, and storytelling opportunities accessible via QR codes linking to the City's MQTCompass website. The project is the first phase of an ongoing collaborative effort led by the City of Marquette's Office of Arts and Culture in partnership with local Tribes, arts, environmental, cultural, economic, and educational institutions. The eight story markers will highlight waterfront access for all, create points of curiosity, and celebrate the stories that shape Marquette. Moreover, the Cultural Trail strives to spark conversations, pique interest, and act as an invitation to explore our community beyond the shoreline, including cultural amenities, organizations, businesses, natural and built landmarks, neighborhoods, parks, and historic downtown.

Tiina Morin, the City of Marquette Arts and Culture Office Manager, has been eager for this project to get off the ground. "In the last ten years, our Office has transitioned from programming to capacity building. There's been a shift in how we think about arts and culture as we move beyond the traditional framework of special events, museums, and gallery walls," Morin, said. "We have taken a broader view on the role of arts and culture in government... it not only creates a vibrant and attractive community but increases the health of our residents, natural environment, and our economy. This perspective might be standard for larger cities, but in a geographically isolated community with a population just over 21,000, I think it's daring."

Fact Checking Reminder

What is disinformation and misinformation? Disinformation comes from the people who create and spread false information. Misinformation comes from people who share that disinformation, not knowing it is untrue. Disinformation may be produced deliberately to help someone retain or gain political power, create chaos, or generate revenue and attention.

Disinformation is **D**eliberate **M**isinformation is a **M**istake

disinformation, check the information sources of a post for additional context that might not be shared. When you see an argument that seeks to pull you in one direction or another, consider the substance of the argument and the motivation of the speaker, then take a step back and consider whether the underlying premise of the argument is valid. When you encounter messages that refer to specific identities, consider if the speaker is trying to influence your opinion of the group through stereotypes.

NON'T CLICK OR SHARE.
 If you quote the bad information, you help spread it.

 DO SHARE ACCURATE INFORMATION.
 Without mentioning the wrong info, set the record straight by sharing the correct messages.

 DON'T ENGAGE PUBLICLY.
 If someone you know is sharing bad info, message them privately & ask them to take it down.

 DO REPORT & BLOCK.
 Report inaccurate info to social media platforms, group administrators & election officials. Block users you don't know who share mis or

Conspiracy theories spread quickly, so check the accuracy of the information

you take in. Look for trustworthy information sources that transparently report data with minimal bias. Above all, exercise skepticism about what you hear and read, and avoid amplifying disinformation by interacting with it online. LWVUS Federal Judiciary Study

At last June's National Convention, the delegates authorized an expedited study of the federal judiciary—courts from District through Appellate and up to the US Supreme Court (SCOTUS). The results from local Leagues will be collated in April/May and submitted for a vote by the delegates to the LWVUS Council in June 2025. The responses to the LWVUS Study Committee's 12 Consensus Questions could lead to a national policy that would allow local, state, and the national LWV to advocate for reform measures, for example,

term limits and/or mandatory ethics rules for the Supreme Court, the end of "judge shopping," or clarification of conflicts of interest requiring a justice's recusal from a case.

Over the next month, our Study Group, composed of David Allen, Sandy Breitenbach, Pri Burnham, Diane Chielens, Jo Foley, Marge Forslin, Jake Guter, Katelynn Jensen, Alec LaPlante, will be reviewing background information about the court system and then grappling with how to respond to the 12 Consensus Questions. Our recommendations will be presented to our membership for their input and approval or revision, then to the LWVUS on or before April 14. accessible. This allows people with disabilities to navigate and interact with the content more easily. Accessible websites improve user experience for everyone and enhance inclusivity by providing equal access for all users.

Since 1996, the ADA has established standards for digital content and the Internet, requiring online businesses, services, and products to be accessible to people with disabilities. However, nonprofits have not had to adhere to these guidelines.

Accessibility received more attention during the pandemic when electronic communication and meetings increased significantly. In 2024, the Department of Justice required state and local government websites to be accessible.

When you visit our website, https://lwvmqt.org/, you can click the disability button (widget) in the lower right corner. This allows users to change the website format, which benefits people with visual impairments, cognitive and neurological disabilities, and ADHD.

Revising our website also allowed us to centralize access to our social media sites and written communications. You can click on the Facebook, Instagram, and YouTube logos on the blue bar at the top and bottom of each website page for direct access to those sites. Our social media sites are also available at the bottom of our newsletters.

The League of Women Voters (LWV) is a non-partisan political organization that encourages the informed and active participation of citizens in government and is one of the most respected and effective grassroots organizations in the world.

On September 19, 1968, the first meeting of the Marquette County LWV was held. With over 100 members at the height of its 38-year existence, eventually membership declined and the Marquette County LWV disbanded in 2006.



In 2017, a small group ignited the revival of a Marquette County chapter. Today the LWV of Marquette County (LWVMC) continues the essential work of providing voters with nonpartisan information about candidates, elections and the mechanics of voting; conducting voter registration drives to encourage the public, especially young people, to become active voters; holding town halls around the county to educate about ballot issues and changes to our laws; observing local boards and governmental entities, including the Board of Canvassers and the

Citizens Redistricting Committee.

Any person who subscribes to the purposes and policies of the League of Women Voters is eligible for membership. Voting members are at least 16 years of age.

Empowering Voters. Defending Democracy.
