Leadership Team's Report

April of 2023 marked 6 years of the resurrected and resurgent League of Women Voters of Marquette County. We have grown from less than a handful of members to holding membership numbers close to 100 for the past two years with an 80% renewal rate and a steady stream of new members. We have held candidate forums, published Voter Guides, and established the VOTE411 online Voter Guide for Marquette County. We have won an award for the celebration of 100 years of women's suffrage. We have marched in parades and demonstrated for reproductive rights. We have registered and educated voters. We have observed multiple civic organizations and shepherded a Voting Rights resolution through our County Commission and many of our Townships.

All of this good work has taken large amounts of time and energy by the original leaders, with a lot of support and work from new Board members and committee workers. But built into our bylaws is a limit to the years one person can be a Board member and Leader. And thank goodness, because such amazing effort requires time to step back, refresh, think more broadly and rest before returning to leadership positions. Last year, the LWVMC Board faced the dilemma that no one person felt ready to take on the duties of President. Darlene Allen was, literally, a matchless act to follow.

True to form, Darlene found another way to keep our League going. Buried in the LWVUS website is a section on Leadership Team Structure that allows for a "streamlined management structure". This structure allows a chapter to divide the "presidential" duties among more than one person. Looking closely at the actual duties led the Board to realize that they fell into different skill sets and we had

people with those skills. For the past year, we have been conducting this governance experiment, with periodic reviews, including requesting critique from the membership. Darlene agreed to be an appointed Board member to help guide this transition, and used her deep knowledge of the details required of a David Allen.

keep us from missing important but sometimes obscure targets. At the April Membership Meeting, the membership adopted by acclamation the revised Bylaws incorporating our flexible leadership structure.

We continue to have a Board, elected by membership, which makes all League decisions. Within the Board are six positions which will be elected by name: Convener, League Liaison, Communication Coordinator, Secretary, Treasurer, and Voter Services Coordinator. Each year, the Nominating Committee (which is elected by membership with one appointed member from the Board) will seek and review candidates for open seats and positions. Per our Bylaws, one person, if considered competent by the Nominating Committee, could run for up to three positions. This allows flexibility that should serve the League for years. It also allows people with varying skill sets to find a place in the League to be leaders.

We want to be out in front of this coming Presidential Election year: supporting our clerks as they find ways to comply with Proposition Two rules, educating our County about the security of our voting system, encouraging every eligible citizen to find a way to vote, and advocating for ways to make every vote count equally. We need to keep observing our County, City, and Township boards and bringing important issues to our candidate forums. We have a new Environmental Committee starting up just as the County and City Commissions are looking at Master Plans for the next five years. And we are gearing up to be more productive in our fundraising to fuel all our endeavors.

Read our report on all we've accomplished this past year and join us for this next exciting year. We live in a complex, contradictory, conflicted time with great peril and great possibilities. But that has been true for all humans at all times. What makes a difference is to find others who care about the deep values you hold, and work together in community to make them reality. The League provides a long-lived, respected platform on which to stand for Human and Voting Rights. Come join us!

Communications Network League communication is designed to elevate the League's messages, educate the public, promote League events and build community trust. Our communications network team helps us to accomplish this goal. The network includes several members who create a quarterly newsletter, manage our website and share pictures and post event and election information on social media. Other members create press announcements, articles and letters to the editor to keep the community educated and up-to-date. These efforts are assisted by members who keep our media contact lists current, who know when and how to best keep the press aware of our events and who monitor our visibility in the various local media outlets.

I have been proud to help build and work with this team since our Marquette County League was re-established in 2017. We will soon be moving on to a new leader for this part of our efforts. At our Annual Meeting we will be electing a new Communication Coordinator. This individual will be an important part of our board leadership team and will help guide our communication efforts into the future. They will help to oversee the content and the distribution of the messages and information shared with the public through our website, social media, and newsletter, and through the local press and other communication outlets.

Two important parts of this communications network are our spokesperson and our board who monitor the messages and the content closely to make sure that it represents our league accurately and well. We also rely on our state and national leagues for messaging. These steps help us to ensure that the League speaks with one voice, which is essential for our effectiveness as an education and advocacy organization. The Communication Coordinator *may* serve as the spokesperson. However, a primary spokesperson will be designated for our League based on board member experience and expertise at the first board meeting of each new board.

I've had great fun working with this team and want to thank them for their efforts. I look forward to welcoming a new member to the role of Communication Coordinator.

Diversity, Equity and Inclusion Committee

This is the second year for this new committee and we are proud to be making progress.

- A new DEI Policy was drafted and approved by the Board.
- We initiated a plan to help incarcerated citizens with voter services.

Any citizen that is in jail but not serving a sentence has the right to register and cast a ballot in any election held during their incarceration. Voter services are not always readily available to jails making voting difficult or impossible for these citizens. Members of the DEI committee met with Greg Zybert (County Sheriff), Brian Steede (Jail Administrator) and Linda Talsma (County Clerk) to discuss how LWVMC might assist in this process.

There were several positive outcomes from this meeting: Brian will be included on our outreach list for voter registration during National Voter Registration Day in September. Prior to national elections, Linda will be given names of eligible voters for potential voter registration forms and absentee ballot applications. Certain League members may be allowed in to assist individuals with their applications. Voter guides will be dropped off at the jail and we agreed to provide copies of our Vote411 information when community wide printed voter guides are not produced.

The first part of the reporting year revolved around the upcoming 2022 election. Members researched venues in Marquette County and created a list for potential forums and town-hall events. Members assisted with the public forum at MAPS and several members took part in educating the community on the Michigan Ballot Initiatives. Weather and unforeseen circumstances reduced the number of planned education events but we were able to hold a presentation at Marquette Township Hall. The presentation included an overview and the pros and cons for each of the three proposals.

After the election, thoughts turned to considering new education programs. A survey was conducted of membership to determine areas of interest. Key topics were League positions, ERA, environmental concerns and gun violence. In collaboration with other League committees, several presentations were given to address these topics: David Allen presented an overview of US and Michigan League advocacy positions and the process for adopting or adding to these positions at the local level. Pri Burnham presented an overview of the National Popular Vote Interstate Compact. A panel discussion on gun violence and safety concerns was held at the May membership meeting where several speakers from the community addressed the topic and members had a chance to ask questions. Plans are ongoing to work with voter services on the Hope Chest Project and the committee is considering a potential Meet-And-Greet session with our state representatives in the fall.

Observers of boards and governmental bodies in Marquette County continued this year, as in previous years. The Observer Corps is following about 10 entities, and forms and minutes from the meetings are available to all LWVMC members. As usual, our observers help develop relevant questions for Vote 411, printed voter guides, and candidate forums. Our observers also help to make our local league visible and relevant to local governments and the general public.

In addition, observers participated in several special projects this year. We had observers at Boards of Canvassers, after the election, in Marquette, Alger, Schoolcraft, and Dickinson Counties. We also participated as election challengers in the general election and for the recount of votes for Prop 2 and Prop 3. Although we still participate as observers of the MICRC, that effort has mostly wound down (there are still a couple of judicial cases that have not been completely resolved).

The Committee looks forward to hearing about - and acting on - other ideas from our members.

League members were treated to a sobering but ultimately hopeful presentation by Peter Sinclair, a climate expert and videographer with the Yale Climate Project, in January and Mike Larson, UP Operations Manager of Michigan Energy Options and recently appointed City Commission member, gave a very informative talk at the Committee's March 30th meeting. Members are also working with the local Climate Action Task Force and with the State League's Environmental Interest Network.

Voter services are central to our work as the League of Women Voters. Volunteers help to plan and organize a variety of voter registration and education activities. These are fun team activities with a variety of volunteer roles to fill.

Voter Guides

Our Vote411 guru Sandy Breitenbach launched our online voter guide for the August, 2022 Primary and the November General Election, with assistance from committee members who contacted local candidates and helped devise questions. And following last-minute editing by Janet Joswiak and Sandy B, 750 of the printed Voter Guides for Marquette County races, along with 500 copies of the LWVMI's Statewide election printed guide, were distributed to libraries, clerks' offices, businesses, grocery stores and other locations all over the County in addition to the guides sent by the Mining Journal to its subscribers.

Candidate Forums

Candidate Forums are an important part of the League's work. The League regularly sponsors forums to offer the public the opportunity to become acquainted with candidates and their views to promote an informed vote on election day. In June, LWVMC provided a candidate forum for Marquette citizens to question three of the four primary candidates for the 109th Michigan House District. Then in October the Marquette Area Public School Board had a large field of candidates; four of the five spent 90 minutes answering nearly 20

Outreach to Children and Teens

The Voter Services Committee continued its focus this year on reaching out to eligible voters in local high schools and on Northern's campus and to "future voters" at the elementary and middle school level. We were invited to classrooms at Michigamme-Republic High School and Marquette Alternative High School, where volunteers narrated a PowerPoint and assisted eligible students with voter registration, applications for absentee ballots, and the mechanics of in-person voting.

In celebration of Constitution Week and National Voter Registration Day and with assistance from the library's Youth Services Department, we once again hosted "Hooked on Voting" for the younger crowd at PWPL. The event included book displays, the opportunity to vote on issues, and, of course, candy and stickers.

On Campus

Voter Services volunteers provided information about registering and voting at NMU's Fall Fest and a new event hosted by the campus organization Social Justice For All: "Rock The Vote." Jo Foley's therapy pal Rosy was a big hit with the campus crowd. In partnership with League member Kate Gunville and her nonpartisan campus organization Northern Votes, Voter Services members hosted a voter registration table at NMU entitled League at the Lodge.

Education

Several local League members were involved in a coalition spearheaded by the nonpartisan Center for Change that brought the "Anatomy of an Election" road show to the UP, with a presentation on campus held on October 5, which was well-attended by LWVMC members. The program's goal was demystifying the voting process and debunking mis- and dis-information about the integrity of Michigan elections.

A Town Hall presentation on the three Ballot Proposals was scheduled to be held on October 18, but had to be postponed due to inclement weather; the rescheduled event, held just prior to the election and without much opportunity to publicize it, was our one disappointment, as the audience at the Marquette Township Community Room consisted of mostly League members.

Get Out The Vote (GOTV)

LWVMC participated in a Get Out The Vote postcard project that was organized by LWVMI for the November 8th Election. Our local League mailed 1,000 postcards to newly registered first-time voters in the Marquette County area. We had 3 postcard parties and 20 members participated. Thank you again to members Ruth Ziel and Barb Owdziej who welcomed members to their homes for enjoyable evenings completing postcards, socializing and sharing some tasty snacks.
